The feeder posts, educational/professional qualification, experience and eligibility criteria for the aforesaid posts shall be strictly as per KVS Recruitment Rules. The applicant shall ensure the accuracy of the information being filled by him/her and the same shall be ensured by controlling Officers concerned without fail before submitting application for LDE/LDCE.

Important Instructions to the Applicants

The Applicant must go through the Instructions, Eligibility conditions/ Criteria mentioned in this notification carefully and ensure that he/ she fulfills all the conditions of eligibility regarding Educational, Professional qualifications, Service experience, Vigilance/ Disciplinary clearance for the post for which he/she applying duly authenticated by the controlling Officer.

1. Utmost caution is to be taken by the Applicants in filling the online application form and the information being provided by him/her should be true and correct as per service records. Suppression of information/providing wrong information shall also be considered as inaccurate/wrong information which may lead to disqualification of the candidature.
2. No change in ONLINE application is permitted once submitted. **Offline application will not be entertained.**
3. The LDE/LDCE will be conducted on the Centers tentatively located in the cities of Regional Offices of KVS.
4. It is mandatory that the Applicant should possess required Degree/ professional degree as per the RRs as on 01.01.2026 for determining length of service and Educational

qualification. Closing date of submission of application form shall be reckoned for CTET (wherever applicable).

5. For the post of Head Master and Trained Graduate Teachers, candidates should possess CTET (Paper-I in case of PRTs applying for Head Master and Paper-II in case of PRTs applying for TGTs). There will be 5% relaxation in qualifying marks for SC/ST/PwBD candidates, which means they need 55% marks (82 out of 150) in CTET. Accordingly, Controlling Officer must verify the year of passing the CTET by the candidate in the online application form.
6. Candidates will have to fill their APAR grading of last six years i.e. 2019-20, 2020-21, 2021-22, 2022-23, 2023-24 and 2024-25.

If APAR for any of the year is not available, controlling authority will issue work and conduct certificate and gradating may be mentioned as per work & conduct. For example: If work & conduct is "Good", then grading will be 4 and if work & conduct is "Very Good" then grading will be 6 and if work & conduct is "Outstanding" then grading will be 8. In case of "Average" work & conduct, the grading will any number be less than 4.

If in any year, the applicant was not in the regular service of KVS, then "NA" is to be mentioned against the APAR grading of relevant year.

7. Merely applying for LDE/LDCE or scoring minimum qualifying marks does not confer any right to the Applicants from feeder cadre to claim for appointment on the promotional post.
8. For candidates applying to the posts through LDE, seniority number will be auto reflected in the online application form as allotted in the updated All India seniority list of concerned post as on 01.01.2025.
9. As per DoPT OM No. F. 36012/1/2002-Estt (Res. II) dated 17.5.2022, no benefit of reservation shall be given on the basis of temporary certificate of disability.
10. The type of examination for LDCE/LDE will be as under:

11. Being a promotional post, minimum qualifying marks in Tier-I/Interview/Personal Interaction/Screening Test (As applicable) for consideration for empanelment will be **40% for Unreserved category whereas 35% for SC/ST and PwBD applicants.**
12. There will be no negative marking.
13. The recruiting agency will upload the images of OMR sheet and answer key on web-portal after the examination for a limited downloadable period for viewing by candidates.
14. Candidates shall be given a provision for submitting online challenges on the portal against the answer key, if any within a stipulated time period through an online window. There shall not be any other mode of submitting application for challenges other than the online window mode. No application shall be entertained once the stipulated time period window is closed. Candidate shall have to pay online on the portal a sum of Rs.1000/- per question towards submitting challenges. This fee shall be non-refundable, however, if the challenge is accepted by the subject experts, the amount paid by concerned candidates shall be refunded to them.
15. There will be interview of 100 marks for the post of Principal & Vice-Principal and Personal Interaction/Screening Test of 100 marks for the post of Finance Officer and Section Officer. However, there will be no interview for the post of PGT, TGT, HM, Assistant Section Officer, Senior Secretariat Assistant and Junior Secretariat Assistant.

16. The Selection for Interview (wherever applicable) will be on the basis of seniority cum qualifying the written examination (Tier I). Such candidates will be called for interview in the ratio of 1:3 as per the vacancies notified for the post.
17. The Final selection will be on the basis of seniority cum qualifying the interview as per the vacancies notified for the post.
18. The Selection for Personal Interaction/Screening Test (for the post of Finance Officer and Section Officer) will be on the basis of marks scored in the written examination (Tier-I) in the ratio of 1:3 as per the vacancies notified for the post.
19. In case where the element of interview is not involved, the final selection will be on the basis of seniority cum qualifying the written examination (Tier -I) as per the vacancies notified for the post.
20. After qualifying the Personal Interaction/Screening Test, Merit List will be prepared on the basis of marks scored in the written examination (Tier-I) for Finance Officer and Section Officer.
21. For promotion to the post through LDE, candidates qualified will be considered as per their inter-se-seniority and subject to availability of vacancies under respective category & subject and possessing minimum benchmark prescribed for promotion & other criteria/condition as per rule.
22. Merit list will be uploaded on KVS website. The marks of applicants will be provided on their respective registered e-mail IDs/applicants login.
23. Services rendered as KVS regular employee only on a specific feeder post(s) will be counted for Service Experience and accordingly services of KVS employee on deputation even in higher/ lower capacity shall be counted at par with the post held in KVS actually. Whereas, counting of past service in other Departments/ organizations at whichever post/ cadre shall not be reckoned as experience required for promotion through LDE/LDCE. Officers/ Officials getting desired level of pay under ACPs/ MACPs/ Senior or Selection Scale/ Deputation/ Adhoc services etc. and claiming their eligibility therefore are also not eligible. Non-regularized period of leave may not be considered while calculating the qualifying service.
24. The candidature of the applicant can be cancelled at any stage, even after conduct of examination, issue of Posting Order, or after joining of promotional post, if it is found, that the information provided by the Applicant to the Reporting Officer is incorrect/incomplete/suppressed or he/she found not eligible for the post as per terms and conditions of notification & Recruitment Rules of KVS.
25. For the post of PGT and TGT, the candidate can apply for one subject only.
26. Primary Teacher can apply for the post of TGT and Head Master. Similarly, Assistant Section Officer can apply for the post of Section Officer and Finance Officer. However such employees those applying for both the posts, have to fill two online application (one each for SO/FO or TGT/HM) and submit their preference as first and second in their each form. In case the candidate is figuring in both the select panel i.e. TGT & HM/ SO & FO, they will be placed only in the select panel for one post as per option given in the online application form.
27. Persons with disability of 40% or more, if so desires, will have to bring their own scribe to assist them in the examination. The facility of Scribe will be allowed to any person with benchmark disability as defined under section 2 (r) of the RPwD Act, 2016 and has limitation in writing including that of speed if so desired by him / her. In case of persons with benchmark disabilities in the category of blindness, locomotor disability (both arm affected-BA) and cerebral palsy, the facility of scribe will be allowed, if so desired by the person. In case of other category of persons with benchmark disabilities, the provision of scribe will be allowed on production of a certificate to the effect that the person concerned has physical limitation to write, and scribe is essential to write examination on his behalf, from the Chief Medical Officer/Civil Surgeon/Medical Superintendent of a Government Health Care Institution as per proforma at Annexure-1. The qualification of the scribe should be at least one step below the qualification of the candidate taking the examination. The candidates with benchmark disabilities opting for own scribe shall be required to submit details of the own scribe at the time of examination as per proforma at Annexure-II. In addition, the scribe has to produce a valid ID proof (PAN, Aadhaar Card, Driving Licence etc.) in original at the time of examination. A photocopy of the ID proof of the scribe signed by the candidate as well as the scribe will be submitted along with proforma at Annexure1. If subsequently it is found that the qualification of the scribe is not

as declared by the candidate, then the candidate shall forfeit his/ her right to the post and claims relating thereto.

28. Compensatory time to be allowed in PwBD case is 20 minutes per hour of examination. All candidates with disability not availing the facility of scribe may be allowed additional time of minimum of one hour for examination of three hours duration. No candidate will be permitted for the LDCE/LDE without the proper Admit Card.
29. **The candidate's response (OMR) sheet and other related papers/documents of examination in respect of this recruitment shall be kept as record only for six months from the date of publication of result. Thereafter, it will be weeded out and disposed in Raddi.**

Instructions for the Controlling Officers

1. The Principal/In-charge Principal in KVs, Deputy Commissioner in Regional Officers, Directors in ZIET, Assistant Commissioner (Estt./II/III) in KVS Headquarter will be the controlling Officer.
2. The Controlling Officers will be responsible for verifying the correctness of the information furnished in application forms/documents submitted by applicant. They have to personally verify the information from the service records/ and documents provided by the Applicant on the authenticity of the data provided by the applicant. In case any information or part thereof is found false/incorrect/suppressed before or after examination/appointment, appropriate action would be initiated against the defaulter controlling officer.
3. The controlling officer will verify the grading of APAR on the basis of APAR if available with them or by obtaining copy from the candidate for relevant years.
4. The eligibility of the candidates will be strictly as mentioned in this notification. Candidates possessing the essential qualifications/service as laid down on this notification will be eligible to appear in LDCE/LDE.
5. The employees under Currency of Penalty as on 01.01.2026 and as on date of submission of application form will not be eligible for applying through LDCE/LDE.
6. If the disciplinary case is pending/contemplated, against any of the employee on the crucial date of eligibility i.e 01.01.2026 as well as on the date of submission of application form, the concerned employee may be allowed provisionally to appear in LDE/LDCE subject to final outcome of the proceedings.
7. The Controlling Officer must ensure and verify the appropriate category & sub-category of benchmark disability of PwBD candidates in the application form as per service record of candidate and in accordance with the suitable category of benchmark disability of applied post mentioned in the notification.
